Our Teen section debuted in Fall 2024 and was a hit so we'll continue in 2025! The category will be Clothing-Junior Boy/Girl in the tagging system and we'll use sizes XS-XL. Any adult-style clothing - a style one of our teen inspectors would not wear - will be subject to the \$0.50 no thank you fee. Our boys section will continue to go up to size 20 and girls will go up to size 16.



Minimum Price: \$2 per hanging clothing item (bundle or create outfits!)



We do not accept water beads, mattresses, or weighted sleep sacks



Stuffed Animals must be NEW or in LIKE-NEW condition



We will continue to have a Room Decor section but it must be for a children's room. Adult home decor will not be accepted.

Consignors reserve a spot by prepaying the Consignor Fee. The fee is \$22.00. This fee is non-transferable and non-refundable.

Earnings

JBF North Bay Consignors earn 60% of the final sale price.

Payment

Consignors receive an eCheck via email within 14 days after each sale. eChecks are printed at home and deposited like a regular check. There is an option to request a mailed check for a \$3 processing fee.





Sign up for SmartPay!

Instead of receiving a check, you'll receive 70% of your sales as credit towards your future purchases at JBF North Bay! It never expires and you can request a check for 60% at any time.







Here's Your Schedule

Consignors pick a drop off time, shopping times, and a pick up time (if you aren't donating your unsold items) when you register. Yes, consignors have a special Presale shopping time for the regular sale AND half price presale **included** in your registration fee! Plus you get access to the sale at all public shopping times!


Step 1: Create A Tagging Account

Go to jbfsale.com to create a JBF Profile. This will generate your consignor number.

Step 2: Sign Up for North Bay Event

Search for Upcoming Events and click sign up.

You can complete these steps anytime and start tagging!



Step 3: Complete your Consignor Registration

You'll register through our ticketing platform called TicketSpice to select your drop off time, shopping times, and pick up time, if you aren't donating.

As you are thinking about prices, consider creating sets or bundles. Put an outfit together, or a set of same-size onesies. Bundle 6 pair of socks together, or several superhero figures. Shoppers love it, and you only have to create one JBF tag!

*Always use numerical sizes for clothing size NB-16/20. For example, if you have clothing marked medium for an item under size 20, please choose the closest numerical size. This will help staff and shoppers know exactly where the item belongs if it is misplaced. Only teen and maternity clothing will use XS-XL sizing.

Helpful Tips

Baby Equipment - Carriers, infant tubs, Pack 'n Play, etc Clothing - Boy - Up to size 20* Clothing - Girl - Up to size 16* Maternity - LIMIT of 20 items of maternity branded clothing (no non-maternity women's clothing) Mommy Mart - Now called Gift Again which is gifts for parents like photo albums, tumblers, etc. LIMIT of 10 items Kids Bedding/Room Decor - Always limited to children's bedroom and bathroom decor (no adult decor) **Shoes** - Shoes must be child/teen appropriate. Adult shoes are not accepted.

Sports Equipment - Includes snow bibs **Toys** - Stuffed animals must be NEW or LIKE-NEW condition

Please note that mattresses are not accepted











Our shoppers LOVE stuffed animals but we only allow NEW and LIKE-NEW stuffed animals. Please do not place them in plastic bags.

What to Consign



Boutique

Designed to feature more expensive products and designer brands, there will be a staffed area near the registers called the Boutique. You may drop off your items to this area and our staff may move high value items into the Boutique throughout the sale to bring attention to your items and also prevent theft.



Printing your tags

Print tags on 8.5" x 11" **white card stock** (not regular paper). Tags automatically print 9 tags per page.

- Select checkboxes next to the tags you want to print.
- Click on Print Selected.
- You can download as PDF or print from this screen.

We do not recommend printing from your mobile device. It is best to download the tags as PDFs and then print. You can also download the tags and print at your local office supply store. Bring your own card stock and save \$\$!

Let's Gather all of your Supplies!

You'll need a few supplies when you are ready to attach your tags. It seems like a long list but you probably have a lot of these items in your house right now!

Gather these supplies to make your prep faster:



- hangers clear self-sealing bags (zip-loc) ribbon/string
 - \cdot zip-ties \cdot clear tape & painter's tape
 - \cdot scissors \cdot safety pins or tagging gun
- clear plastic wrap
- hole-punch

Preparing Your Items & Attaching Tags

Now that your JBF tags are printed, cut them apart and sort them by gender, size, and type.

NON-CLOTHING TIPS

- Attach tag securely. Make sure tape does **not** cover the barcode on tag.
- Secure all pieces together and tape bags closed
- Use **painter's tape** to secure tag on books
- LIMIT: 10 of your best NEW items for Gift Again (parent section which is called Mommy Mart in the tagging system)

CLOTHING

Hanging & Tagging Clothing

Attach JBF tag with safety pin or tagging gun. LIMIT: 20 in-style maternity clothing items



Hanger Direction

Be sure the hanger hook opens to the left, like a question mark. Attach JBF tag to front of item on the right side.





Creating Outfits

You have the option to bundle items into sets. Secure pieces to hanger using safety pins. Indicate on the tag what is included in the set. Remember there is a \$2 minimum per hanging item.

Tagging Gun

If you use a tagging gun to attach JBF tags, only puncture the garment tag or an inside seam so that you do not damage the fabric. **Do not use a tagging gun directly on the fabric of the garment.** If you unsure how to place the tagging gun barb, please use a safety pin. See the <u>tagging gun page</u> for more info.



Prep - Clothing





Hanging pants and skirts

Use safety pins through sturdy waistlines to secure pants and skirts to the **TOP BARS** of hangers. Put pins on both sides to prevent sliding.



Accessories

Use clear bags to bundle sets of socks, hair accessories, infant mittens, and hats.

Accesssories will be hung with hooks intead of hangers.



Hats

Simply attach JBF tag to hats using a safety pin or tagging gun. No need to use a bag.

Each hanger must only have one tag!



Bundling Onesies and Hanging Multiple Items on a Hanger

Multiple items—that are all the same size — can be hung on a single hanger. Attach one item to the hanger and use safety pins to attach the others to the back of the first item. Indicate on tag what items are bundled and only use one tag.

Using a Tagging Gun to Attach JBF Tags

Many JBF Consignors find it much faster to attach JBF tags to items using a tagging gun instead of safety pins. Please follow these Tagging Gun Guidelines to prevent damage to your items.

Garment Tag

If the clothing has a garment tag at the neckline, always puncture the garment tag when attaching your JBF tag





🧿 Insi

Inside Seam

If the clothing does NOT have a garment tag at the neckline, puncture the inside seam when attaching your JBF tag

If the clothing does NOT have a garment tag OR an inside seam at the neckline, puncture the item's **LEFT armpit seam** when attaching your JBF tag (so that your tag is on the right as you face the item).

Shoes

Shoes should be in like-new, gently used condition with no scrapes, worn toes, dirt, or scuff.

Attach shoes together securely with a zip tie or ribbon.

We accept all sizes of shoes but they MUST be **child/teen-focused** (ex: no stilettos or adult shoes).

Bring your best!











LARGE ITEMS

Items that are large or heavy require a yellow claim ticket. Print your tag but don't attach it to your item. Bring it to drop off and the staff will have all of the supplies you need!



Please note that we cannot accept mattresses. Bassinets and cribs are ok.

Safety Matters

Just Between Friends is dedicated to keeping families safe. That's why we want you to have up-to-date information on safety and recalls for items you're still using and for items you want to sell at JBF.

As a Consignor, it is your responsibility to check all of your items for recalls. If an item is recalled, it cannot be sold at JBF. If you've installed the recall repair, it is safe to use and sell at JBF.

We also have very high standards when it comes to selling **Car Seats, Cribs,** and **Infant Sleep Products** (scroll down to read more). Plus, you'll find furniture tip-over prevention and drawstring safety information in the pages to follow.



Bumbo Seats

All Incline Sleepers

are no longer considered safe for babies to sleep in. Therefore, you may only sell items at JBF in which babies lie FLAT to sleep.





All Crib Bumpers

are no longer considered safe and cannot be sold at JBF.

Infantino Infant Carriers

Go Forward 4-in-1 Evolved Ergonomic, Flip Front2back, and Up Close Newborn infant carriers were recalled in February 2020 due to buckles which can break, posing a fall hazard.

Immediately stop using and visit www.infantino.com for replacement options.





SAATY MATTERS TOP 10 SAFETY ALERTS





B.O.B. Strollers

BOB jogging strollers manufactured between January 2009 and September 2015 were recalled for front wheel attachment issues. The replacement thru-bolts are also faulty (model number is S11393700). The bolt can fracture during use, allowing the front wheel of the stroller to detach, posing a risk to the child in the stroller and the adult pushing the stroller. There is no current remedy offered by the manufacturer that makes this item safe to sell at JBF.



Macleran Strollers

All Maclaren single and double umbrella strollers sold between 1999-2009 were recalled for potential finger amputation from hinge mechanism. Consumers should immediately stop using these recalled strollers and contact Maclaren USA to receive a free repair kit. Strollers with repair kit installed are safe to use and to sell at Just Between Friends.



Boppy Lounger

Infants can suffocate if they roll, move, or are placed on the lounger in a position that obstructs breathing, or roll off the lounger onto an external surface, such as an adult pillow or soft bedding that obstructs breathing.

Consumers should immediately stop using the recalled loungers and contact The Boppy Company for a refund. boppy.com/pages/loungerrecall

4moms MomaRoo and RockaRoo

When the swing or rocker is not in use, their restraint straps can dangle below the seat and non-occupant crawling infants can become entangled in the straps, posing a strangulation hazard.

Go to 4momsrecall.expertinquiry.com to register for a free strap fastener. Once installed, it is safe to use and to sell at JBF.



When the bather is lifted and/or carried with an infant in it, its folding wire frame can suddenly disengage from the side hinge.

Bathers with FIVE rivets are recalled. All others are safe to use and to sell at JBF.





Chicco Polly High Chairs

This recall involves a range of Chicco Polly highchairs with pegs on the back legs intended for tray storage manufactured prior to October 13, 2010 and sold from 2005 through July 2012.

Contact Chicco to request a free peg cover kit. Once this fix is installed, it is safe to use and to sell at JBF.







SAFETY MATTERS JBF SAFETY STANDARDS

CAR SEATS: WAIVER REQUIRED

All Car Seats must be checked for recalls before selling at JBF.

A completed **Car Seat Waiver is required** for all car seats, booster seats, and bases. It is included at the end of this Consignor Guide <u>here</u>.

CRIBS: CHECKLIST REQUIRED

All Cribs made before June 28, 2011 are no longer considered safe for infants.

For cribs manufactured on or after this date: a completed **Crib Waiver is Required**. It is included at the end of the Consignor Guide here.



INFANT SLEEP PRODUCTS



JBF accepts cribs, bassinets, cradles, bedside sleepers, and play yards that meet current Safety Standards set by the Consumer Product Safety Commission and JBF quality/condition standards.

For all other items marketed or intended to provide a sleeping accommodation for an infant up to 5 months of age, the product must have a stand, meet stability requirements, and have a side height of at least 7.5 inches.


All other infant sleep products are not accepted for resale at JBF.

HELP STOP TIP OVERS



All furniture over 27-inches will be sold with safety straps to anchor furniture to the wall safely. We will provide safety straps for your items when you drop it off at the JBF sale.

DRAWSTRING SAFETY



Upper Outerwear WAIST Drawstrings should be 3-inches or shorter and sewn to garment at mid-point so string cannot be pulled to one side for sizes 2T-16.

Upper Outerwear NECK Drawstrings should be removed completely for sizes 2T-12.











You did it!

Now that your items are tagged, you'll want to pack items **organized by type and size** so that your Drop Off process is easy and fast.

TUESDAY, SEPTEMBER 30: 4PM-7PM WEDNESDAY, OCTOBER 1: 8AM-1PM SONOMA COUNTY FAIRGROUNDS 1350 BENNETT VALLEY RD, SANTA ROSA, CA 95404



Plan for 30-60-minutes to drop off your items and a bit longer if you have 250+ items. Park in the back parking lot, enter with 1 item and your QR code, **check In,** grab a cart, and unload your car. We'll have carts and racks you can borrow or you can bring your own.



Place clothes on racks by gender and size to the right of the 1st letter of your Consignor # (this will make sense onsite). All other items go to appropriate areas clearly marked. All items will be inspected for quality after drop off is complete. Consignors will be charged \$0.50 for each item pulled from the floor so please inspect your items carefully again at drop off.



Our Safety & Recall Specialist will inspect all items children sit in, are carried in, or sleep in for recalls and safety. Please review recalls at <u>https://www.cpsc.gov/Recalls</u> ahead of time. You are the first line of defense to keep our kids safe!

Inspection Process

Once your items are on the sales floor, our staff looks at each item to check for cleanliness, functionality, and safety. Consignors are expected to perform these checks at home and again at drop off. Disappointed shoppers who find stains, holes, etc will not return and it **will** hurt your sales!

- Items must be clean, stain-free, odorless, and must not have any holes, including holes created by the improper use of a tagging gun.
- Consignors will be given grace for one item that is not in proper form. (We understand things fall from hangers at the event sometimes. We do our best to clean them onsite if that happens). Any items after that will be charged \$0.50 per item that must be pulled from the sales floor. This will be removed from your consignor check at the end of the sale. Consignors may be charged a disposal fee for large items that are not picked up but cannot be donated because of condition, recall, etc.
- Double check shoes carefully! Shoes, boots, and cleats with dirt, holes, or excessive wear will be pulled and accessed the \$0.50 fee per item.
- If a product does not have working batteries, consignors will be charged \$1.25 per battery.
- Please be sure to check the CPSC recall list at <u>https://www.cpsc.gov/Recalls</u>. It is illegal to consign or sell recalled items. Items that have been fixed like the addition of a Mamaroo safety strap are acceptable.


